Years Maximum Pensionable Earnings (YMPE)	\$57,400.00
Maximum pension plan contributions	\$27,230.00
Defined Benefit limit	\$3,025.56 per year of pension plan credited service

At times, you may find yourself speaking with colleagues and comparing information regarding your financial situation, compensation and your pension plan entitlements. It is important to remember information such as salary, service, age and marital status impact your pension. You may not have all of these in common with your colleagues. If you are seeking information regarding your entitlement, please contact us directly.

It is also important to keep in mind there are very strict rules regarding privacy and protection of personal and confidential information. The Pension & Benefits Office has a duty to maintain confidentiality and can discuss or provide personal information to you. A colleague is not bound by the same confidentiality and privacy requirements.

2018 Pension Statements

Legislation indicates the December 31, 2018 pension statements must be available to all members of the pension plan on or before June 30, 2019. The Pension & Benefits Office will provide more information once the statements are available.

Important Information Regarding Benefit Coverage

On occasion the Pension & Benefits office receives emails or phone calls regarding benefit claims that have been declined or a portion of the claim paid leaving some of the cost to be paid by the plan member.

We have frequently reminded plan members to obtain a predetermination for any health or dental expense which you would be unwilling or unable to pay for. Whether it is \$3.86 in dental expenses which your dentist charged over the Ontario fee guide, \$50 for a second cane, or \$1,000 in vaccinations there may be times when an expense is not covered under the Sun Life benefit plans.

Sun Life adjudicates the claims based on the benefits which have been negotiated or provided by the University. There are reasonable and customary limits on certain services and supplies. The next time a claim hasn't been paid to the level you think it should we ask that you take a few minutes to review your benefits coverage through the Sun Life member website, their mobile app or the benefits booklet available in yu link. If you still think you are owed money, please contact Sun Life to discuss the claim with them.

Understanding your Pension & Benefits Series

The Pension & Benefits office (P&B) has put together a new workbook and workshop series on pension & benefits at York. The sessions along with the workbook are designed to create a conversation and learning opportunity for you to further understand how your pension & benefits play a role in your employment at York.

It is in the best interest of all pension plan members to have a full understanding of how the pension plan works, how CRA limits impact you, options and investment information. Waiting until a few months prior to retirement may result in unforeseen obstacles affecting your decision. Once you have begun receiving a monthly pension it is really too late to question items affecting your final pension such as credited service from a decade earlier, pension plan contributions from twenty years ago or how the monthly pension may change. If you have questions or concerns regarding your pension they need to be raised in the year you think there is a concern. The Canada Revenue Agency, the Pension & Benefits Act and the York Pension plan text have limitations that prevent the Pension & Benefits office from making certain changes to a prior year. By attending our seminars you will have a better understanding of your entitlements.

The series is made up of four (4) sessions which walk through different sections of the workbook. The sessions will focus on:

- Session 1: Life events and how they may impact your pension & benefits
- Session 2: Pension plan at York
- Session 3: Retirement planning and the aspects of your pension & benefits after retirement
- Session 4: Leaves and reduced workloads, and what would happen if you left York before retirement

Each section comes with extended learning questions which will be addressed as part of the sessions in a fun and interactive way.

We hope you will be able to join us for some or all of these sessions depending on your current needs.

Delisted Service Providers

Don't be out of pocket.

Sun Life regularly looks at the claiming and administrative practices of medical and dental healthcare service providers and pharmacies. Sometimes, their review can lead to "delisting". This impacts you. If you receive healthcare services or supplies from a delisted provider, Sun Life **will not** reimburse you for your expenses. You can still choose to obtain services or supplies from a delisted provider; however, your claim will be denied. Look at the delisted providers before making an appointment, just to be sure!

Going on a leave, retiring, or resigning can be stressful and confusing. In most instances we need your department to send the Employee Transaction Form (ETF) to Human Resources for us to be able to begin our processes. If you have not received something from us in the time periods below, please be sure to check with your department first to find out if they have sent the ETF.

Event	Due date for Employee Transaction Form
Leave of Absence	Four weeks before leave commences
Retirement	Three months before retirement date
Sabbatical	Three months before sabbatical commences

Request	Timeline for Pension & Benefits Action
Responding to emails	Three business days
Pension & Benefits Updates i.e. dependent or benefit changes	Forms must be received by end of day Thursday in order for information to be sent to Sun Life each Monday morning – Sun Life will update your record, where applicable, by end of day Wednesday
Pension & Benefits Updates i.e. beneficiary changes	Five business days from receipt of completed application
Letter of Confirmation i.e. Benefit coverage confirmation	Ten business days
Responding to Letters from external sources i.e. lawyers	Fifteen business days
