Be aware

Your employee benefits are a valuable asset to you and your family and with that come responsibilities on your part to ensure coverage. Coverage is not automatic. If you are eligible for benefits coverage you need to sign up for benefits to be covered. Similarly, when you have a change in family status, i.e., a new spouse or child, they need to be enrolled to your benefit plan or they will not be covered. Benefits coverage is not backdated.

Leaving the University

Whether you are leaving the University because of your contract ending, resigning or retiring your ability to submit claims after your benefits coverage is shortened. As an active employee, you have fifteen months to submit a benefits claim, however, when your contract has ended, you have resigned or retired you only have 90 days to submit claims that were incurred while you were an active employee. For example, if you retire July 1st and have a benefit claim as an active employee in June, you have 90 days from July 1st to submit the claim for reimbursement.

Pension & Benefits Availability

Often members will arrive at the Pension & Benefits office to drop off forms and ask a quick question. When members arrive at the office unexpectedly, unfortunately we are not always available to meet with you. In order to ensure you receive the best customer service experience possible and have your questions answered in a detailed fashion, we encourage you to book an appointment.

Going on a leave, retiring, or resigning can be stressful and confusing. In most instances, we need your department to send the Employee Transaction Form (ETF) to Human Resources for us to be able to begin our processes. If you have not received something from us in the time periods below, please be sure to check with your department first to find out if they have sent the ETF.

Event	Due date for Employee Transaction Form
Leave of Absence	Four weeks before leave commences
Retirement	Three months before retirement date
Sabbatical	Three months before sabbatical commences

Request	Timeline for Pension & Benefits Action
Responding to emails	Three business days
Pension & Benefits Updates i.e. dependent or benefit changes	Forms must be received by end of day Thursday in order for information to be sent to Sun Life each Monday morning – Sun Life will update your record, where applicable, by end of day Wednesday
Pension & Benefits Updates i.e. beneficiary changes	Five business days from receipt of completed application
Letter of Confirmation i.e. Benefit coverage confirmation	Ten business days
Responding to Letters from external sources i.e. lawyers	Fifteen business days
